2. The Registrar General, High Court of Madras in his letter 3rd read above has sent a proposal for further continuance of 34 additional posts for each of the 7 units of Labour Courts and further continuance of 22 additional posts sanctioned to the Chennai unit functioning in the State of Tamil Nadu beyond 28.9.2012.

3. The Registrar General, High Court of Madras has stated that the High Court recommends the proposal for further continuance of 34 additional posts for each of the 7 units of Labour Courts and 22 additional posts out of 34 additional posts sanctioned to the Chennai unit sanctioned in the GO first read above and functioning in the State of Tamil Nadu beyond 28.9.2012 for a further period of one year from 29.9.2012 to 28.9.2013.

The Government carefully examined the proposal of the Registrar General, High Court, Chennai and accord sanction for further continuance to the 34 additional posts for each of the 7 units of Labour Courts and 22 additional posts out of 34 additional posts sanctioned to the Chennai unit functioning in the State of Tamil Nadu beyond 28.9.2012 as in the Annexure I, II, and III (A-H) for a further period from 28.9.2012 upto 27.9.2013.


