ORDER:

Hon'ble Minister for Labour has made an announcement on the floor of the Assembly on 11-5-2012 that Siddha Unit will be opened in 10 ESI Dispensaries at Triplicane, Avadi, Korattur, Ambur, Ranipet, Dindigul, Tirunagar, Tiruppur-I, Udumalaipet and Kattor-1.

2.In the letter 1st read above, the Director of Medical and Rural Health Services (ESIS), has sent the proposal regarding opening of Siddha Unit at 10 ESI Dispensaries of the following Regions in Tamil Nadu:-

Coimbatore Region	Udumalaipet, Kattor-1, Tiruppur-I

3. The Government after careful examination, accept the proposal of the Director of Medical and Rural Health Services (ESIS) and sanction the opening of Siddha Unit at 10 ESI Dispensaries in the four Regions as detailed in paragraph 2 above.

4. Sanction is also accorded for the creation of the following posts in connection with opening of Siddha Unit at four Regions in Tamil Nadu:-

5. The incumbents of the posts sanctioned in paragraph 4 above are eligible to draw the pay and allowances as per rules in force, as applicable to the related scales of pay.

6. The Director of Medical and Rural Health Services (ESIS) is directed to post the above staff in the 10 ESI Dispensaries of four Regions in Tamil Nadu not before one month from the date of actual implementation of the scheme in the said ESI Dispensaries in their respective Regions.

7. The Director of Medical and Rural Health Services (ESIS) is requested to review the working of this scheme after six months of its introduction and to furnish a report to Government and also to follow the instructions for opening of Siddha Units in 10 ESI Dispensaries

issued by the ESI Corporation, New Delhi in the establishment of Siddha Units in 10 ESI Dispensaries in four Regions in Tamil Nadu as detailed in letter 2nd read above.

10. The expenditure sanctioned in para 8 above, shall constitute an item of "New Instrument of Services". The approval of the legislature will be obtained in due course. Pending approval of the Legislature the expenditure may initially be met from an advance drawn from contingency fund regarding which orders will be issued separately in Finance (BG-I) Department. The Director of Medical and Rural Health Services (ESI) is requested to apply for sanction of contingency fund in the prescribed format along with the copy of this order to Government in Finance (BG-I) department and to send necessary proposal for Supplementary Estimate for inclusion of this expenditure in the Supplementary Estimates for 2012-2013 to Government without fail.

11. The expenditure will be initially incurred by the State Government out of the Budgetary provision/ Additional Provision now sanctioned for 2012 - 2013 and fully reimbursed from the Employees State Insurance Corporation for the first five year period, from the date of implementation of Employees State Insurance Scheme in the above area and thereafter, the expenditure shall be shared between the Employees State Insurance Corporation and the State Government in the agreed ratio of 7:1.
