ORDER:

In the Government Order first read above the minimum rates of wages for the employment in Auto Rickshaws and Taxis were last revised under the provisions of the Minimum Wages Act, 1948. The Government have now proposed to further revise these minimum rates of wages for employment in Auto Rickshaws and Taxis.

NOTIFICATION

The following draft of a Notification which it is proposed to issue in exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) is hereby published for information of all persons likely to be affected thereby, as required by clause (b) of sub-section (1) of section 5 of the said Act.

2. Notice is hereby given that the draft Notification will be taken into consideration on or after the expiry of two months from the date of publication of this Notification in the <u>Tamil Nadu Government Gazette</u> and that any objection or suggestion, which may be received from any person with respect thereto before the expiry of the aforesaid period will be considered by the Government of Tamil Nadu. Objection or suggestion, if any, should be addressed to the Secretary to Government, Labour and Employment Department, Secretariat, Chennai-600 009 through the Commissioner of Labour, Chennai-600 006.

DRAFT NOTIFICATION

In exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in supersession of the Labour and Employment Department Notification No. II(2)/(LE)/476/2003, published at pages 271 of Part II-Section 2 of the <u>Tamil Nadu Government Gazette</u>, dated the 2nd July 2003, the Governor of Tamil Nadu hereby revises the minimum rates of wages payable to the classes of employees in the employment in Auto Rickshaws and Taxis in the State of Tamil Nadu, specified in column (1) of the Schedule below, as specified in the corresponding entries in column (2) thereof.

THE SCHEDULE.

EMPLOYMENT IN AUTO RICKSHAWS AND TAXIS.

	Minimum rates of wages Rs. Ps
Classes of employees	
(1)	(2)
Drivers in Autorickshaws	Rs. 138 .50 per day (or)
(fitted with meters)	Rs. 3600 per mensem
Drivers in Taxis	Rs. 170 per day (or)
(fitted with meters)	Rs. 4410 per mensem

EXPLANATIONS.- (1) <u>Dearness Allowance</u>: In addition to the above minimum wages, the employees shall be paid dearness allowance as follows:-

- (i) The dearness allowance is linked to the Average Consumer Price Index Number for Chennai City for the year 2000 (that is 475 points with base 1982 = 100) and for every rise of one point over and above 475 points, an increase of Rs.7.55 (Rupees Seven and paise Fifty Five only) per month shall be paid as dearness allowance.
- (ii) The revision of dearness allowance shall be effective from the first April of every year on the basis of the average of the indices of the preceding twelve months, that is from January to December.
- (iii) The first calculation shall be effective from the date of publication of this Notification in the <u>Tamil Nadu Government</u> <u>Gazette</u> based on the Average Consumer Price Index of the previous year.
- (2) (i) The daily rates of minimum wages include the element of weekly holiday wages also,
 - (ii) To arrive at the daily rate of dearness allowance, monthly rates of dearness allowance shall be divided by 26.
- (3) Wherever the existing wages are higher than the minimum rates of wages fixed herein, such existing wages shall be continued to be paid.
