**ORDER :**

The Commissioner of Labour in his letter read above has sent proposals to constitute a committee for revision of Minimum rates of wages for employment in Textile Mills (Other than Apprentices). The Government accept the recommendation of the Commissioner of Labour and have now decided to constitute a committee under section 5(1) (a) of the Minimum wages Act, 1948 (Central Act XI of 1948), to hold enquiries and advise them in the matter of revision of the minimum rates of wages for the employment in Textile Mills (Other than Apprentices).

2. The Committee shall be treated as a First Class Committee for the purpose of Travelling Allowance and Daily Allowance. The Chairman of the Committee is authorised to countersign the Travelling Allowance bills of the non-official members of the Committee and the Assistant Commissioner of Labour in the O/o the Deputy Commissioner of Labour, Coimbatore is authorised to draw and disburse the amount to the non-official members.

3. The expenditure on account of the Travelling Allowance for non-official members shall be debited to the following head of account:

4. The Chairman of the Committee is requested to take necessary action to submit the report of the Committee to Government within six months from the date of issue of order.

5. The term of office of the non-official members of the committee shall be six months from the date of issue of order.

6. The appended Notification, constituting the committee will be published in the Tamil Nadu Government Gazette, both in English and Tamil. The Works Manager, Government Central Press, Chennai-600 079 is requested to publish the Notification in the coming issue of Tamil Nadu Government Gazette and send five copies of the Gazette to the Government for reference and record.
