ORDER:

The Government of Tamil Nadu have enacted the Tamil Nadu Manual Workers (Regulation of Employment and Conditions

of Work) Act, 1982 for the welfare of manual workers. Sixty seven employments are listed in the Schedule to the said Act. In the G.O.first read above, the Tamil Nadu Manual Workers Social Security and Welfare Board was formed on 17.3.1999. Subsequently, in the references second to tenth read above, 9 Welfare Boards were formed for Auto Rickshaw and Taxi Drivers, Tailors, Hair Dressers, Washermen, Palm Tree Workers, Handicraft workers, Handloom and Silk Weaving workers, Footwear and Tannery workers and Artists. Accordingly separate Welfare Schemes to each of the 9 Welfare Boards were also formulated and notified. Then, due to administrative reasons, the said 9 Welfare Boards were amalgamated with the Tamil Nadu Manual Workers Social Security and Welfare Board in the G.O.11th read above.

- 2. His Excellency the Governor of Tamilnadu, in his address in the Tamilnadu Legislative Assembly on 24.5.2006 has, among others, announced that the Welfare Boards for the workers employed in the unorganized sector will be rejuvenated. Accordingly, the Commissioner of Labour in his letter 12th read above has sent a detailed proposal for establishment of 9 Welfare Boards.
- 3. After careful consideration the Government direct that the following 9 Welfare Boards be established separately and be notified in the Tamil Nadu Government Gazette under Section 6 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 as appended to this order;
 - The Tamil Nadu Auto-Rickshaw and Taxi Drivers Welfare Board.
 - 2. The Tamil Nadu Washermen Welfare Board.
 - 3. The Tamil Nadu Hair Dressers Welfare Board
 - 4. The Tamil Nadu Tailoring Workers Welfare Board.
 - 5. The Tamil Nadu Palm Tree Workers Welfare Board
 - 6. The Tamil Nadu Handicrafts Workers Welfare Board
 - 7. The Tamil Nadu Handloom and Handloom Silk Weaving Workers Welfare Board

- 8. The Tamil Nadu Footwear and Leather Goods Manufactory and Tannery Workers Welfare Board.
- 9. The Tamil Nadu Artists Welfare Board.
- 4. The existing Tamil Nadu Manual Workers Social Security and Welfare Board be allowed to continue to function for the workers not covered in the above Welfare Boards.
- 5. Orders regarding the nomination of members to each of the nine Boards will be issued separately.
- 6. The Government approve the Tamil Nadu Manual Workers Social Security and Welfare Scheme, 2006 and Welfare Schemes 2006 pertaining to above mentioned 9 Welfare Boards. Orders notifying the above said welfare schemes will be issued separately.
- 7. The Government also direct that the registration fee of Rs.100/- and the renewal fee of Rs.10/- collected once in two years from the manual workers be dispensed with.
- 8. The Government also direct that no separate Board need be formed for workers engaged in stone cutting, as the workers engaged in stone cutting work can register in Tamil Nadu Construction Workers Welfare Board.
- 9. The appended notification regarding the formation of 9 Welfare Boards shall be published in the extraordinary issue of the Tamil Nadu Government Gazette dated 1st September 2006 in English.
- 10. The Secretary to Government, Tamil Development Culture and Religious Endowments (Translations) Department, Secretariat, Chennai-600 009 is requested to send the Tamil translation of the Notification to the Works Manager, Government Central Press, Chennai-600079.
- 11. The Works Manager, Government Central Press, Chennai is requested to send 50 copies of the Notification to the

Government for reference and record. He is also requested to send 50 copies of the Notification to the Commissioner of Labour, Chennai-6 direct.
