ORDER:

In the G.O. 2nd read above, the following nine Welfare Boards have been formed and notified under Section 6 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982.

1. The Tamil Nadu Auto-Rickshaw and Taxi Drivers Welfare Board.
2. The Tamil Nadu Washermen Welfare Board.
3. The Tamil Nadu Hair Dressers Welfare Board

4. The Tamil Nadu Tailoring Workers Welfare Board.
5. The Tamil Nadu Palm Tree Workers Welfare Board
6. The Tamil Nadu Handicrafts Workers Welfare Board
7. The Tamil Nadu Handloom and Silk Weaving Workers Welfare Board
8. The Tamil Nadu Footwear and Leather Goods Manufactory and Tannery Workers Welfare Board.
9. The Tamil Nadu Artists Welfare Board.

2) In the G.O. second read above, orders were also issued for the continuance of the existing Tamil Nadu Manual Workers Social Security and Welfare Board for the workers not covered in the above other Welfare Boards. In the G.O.third read above orders were issued for the formation of Tamil Nadu Goldsmiths Welfare Board and Tamil Nadu Pottery Workers Welfare Board.

3) In the Government Orders fourth to fifteen read above orders were issued notifying the welfare schemes 2006 for the Tamil Nadu Manual Workers and Social Security Welfare Board and other welfare boards.

4) The Commissioner of Labour in his letter first read above has requested the Government to sanction a sum of Rs.261.04 (Rupees Two crores sixty one lakhs and four thousand only) for the year 2006-2007 to the Welfare Boards for administering the Boards and the schemes. He has also stated that in respect of the Auto Rickshaw and Taxi Drivers Welfare Board the estimated annual expenditure for the cost of administering the scheme including staff salary is Rs.33.85 (Rupees thirty three lakhs and eighty five thousand) and the Auto Board has got with own funds to run and meet the entire expenditure. He has also requested the Government to sanction 40 posts to the Welfare Boards except Auto Rikshaw and Taxi Drivers Welfare Board and 10 posts to the Auto Rikshaw and Taxi Drivers Welfare Board.

5) The Government after careful consideration accept the proposal of the Commissioner of Labour and sanction is accorded

to incur an expenditure of Rs.261.04 lakhs (Rupees Two crores sixty one lakhs and four thousand only) towards the expenditure on welfare schemes and staff of the existing Tamil Nadu Manual Workers Welfare Board and 8 other Boards except Tamil Nadu Auto Rickshaw and Taxi Drivers Welfare Board for the year 2006-2007.

6) The Government accord permission to the Tamil Nadu Auto Rickshaw and Taxi Driver Welfare Board to incur an expenditure of Rs.33.85 lakhs (Rupees thirty three lakhs and eighty five thousand only) towards expenditure on welfare schemes and staff from its own funds.

7) Sanction is accorded for the creation of the following 40 posts for the existing Tamil Nadu Manual Workers Welfare Board and other 8 Boards except Tamil Nadu Auto Rickshaw and Taxi Driver Welfare Boards:-

8) The Government direct that 27 employees working in the existing Tamil Nadu Manual Workers Welfare Board shall be accommodated in the above newly created 50 posts.

9) The expenditure sanctioned in para 4 above shall be debitable to the following head of account:-

2230.Labour and Employment 01.Labour-111. Social Security for Labour JA. Grants to Unorganised Labour Board 09. Grants in aid 01. Grant for Current Expenditure

10) The Government authorize the Commissioner of Labour to allocate the existing staff from one Board to another Board according to the needs. The Government Grant will be released through the Commissioner of Labour. The Commissioner of Labour is authorized to draw the amount after Appropriation Act is passed by the Legislature on Revised Budget Estimate 2006-2007 and to apportion the amount to the Boards according to the needs without exceeding the overall allotment.

11) The Government direct that the Commissioner of Labour shall control and supervise the implementation of these Welfare Schemes and these Welfare Schemes shall be implemented at District/Taluk level through Labour Department Officials.

12) The Administrative Officers of the Welfare Boards shall send budget proposals including RE & FMA through the Commissioner of Labour to Government.

13) The Commissioner of Labour is the estimating, reconciling and controlling authority for the implementation of this scheme

14) The Secretary of the Welfare Boards shall send the monthly reports regarding the implementation of the Welfare Schemes through the Commissioner of Labour to Government.
