ORDER:

In G.O.first read above the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 was formulated. Under clause 13 of the Tamil Nadu Construction Workers Scheme 1994, every registered, manual worker who has completed 60 years of age is eligible for pension, if he has continued as such worker for a continuous period of not less than five years; provided that a manual worker who has not completed 60 years of age but registered with the Board for a continuous period of five years, is also eligible for pension if he has become disabled due to sickness and incapacitated from normal work. Under the said clause 13(3) the quantum of pension shall be approved by the Government.

2. In the G.O.second read above, the Government have approved a Pension Scheme sanctioning a sum of Rs.200/p.m. towards pension to each eligible construction worker registered with the Tamil Nadu Construction Workers Welfare Board from the year 2000-2001 The pension scheme is implemented by the Tamil Nadu Construction Workers Welfare Board out of its own sources.

- 3. The Commissioner of Labour, in his letter third read above, has sent proposal to the Government for enhancement of quantum of pension amount from Rs.200/- to Rs.300/- p.m. to the construction workers registered with Tamil Nadu Construction Workers Welfare Board.
- 4. In the Cabinet Meeting held on 7.7.2006, the Cabinet discussed the proposal for enhancement of monthly pension from Rs.200/- to Rs.300/- for Tamil Nadu Construction Workers and decided to enhance the pension from Rs.200/- to Rs.300/- p.m. with effect from 1.9.2006 to the construction workers registered in the Tamil Nadu Construction Workers Welfare Board.
- 5. Based on the Cabinet decision, the following orders are issued:-
 - (i) The Government accord sanction for the enhancement of the pension from Rs.200/- to Rs.300/- per month to the Construction workers registered in the Tamil Nadu construction Workers Welfare Board, who have completed 60 years of age on the date of application for pension and who have been a registered worker of the Board for a continuous period of not less than 5 years and to a manual worker, who has not completed 60 years of age but registered with the Board for a continuous period of 5 years, and is disabled due to sickness and incapacitated from normal work
 - (ii) The enhancement of pension of Rs.300/-p.m. will be implemented with effect from 1.9.2006.
 - (iii) The expenditure for this proposal will be met from the Tamil Nadu Construction workers Welfare Board Fund itself.
 - (iv) This Pension Scheme will be reviewed once in three years.
