### **ORDER:**

Under the Section 6 of Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982, the Tamil Nadu Construction Workers Welfare Board was formed with effect from 1.11.1994 for the welfare of manual workers engaged in Construction or maintenance of dams, bridges, roads or in any building operator or stone breaking or stone crushing or construction of pandals or brick manufactory other than the brick manufactory under the Factories Act 1948. The Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme 1994 was also formulated to provide welfare measures to the manual workers engaged in the above employments .

2. Under Clause 5 of Tamil Nadu Manual Workers (Construction workers) Welfare Scheme 1994, manual worker may register his name in the above Board after payment of registration of Rs.25/-. Under Clause 6 of the said Scheme every manual worker shall renew his/her initial registration after payment of Rs.10/- once in two years.

3. The Chairman, Tamil Nadu Construction Workers Welfare Board, has sent proposals to waive the existing registration and renewal fee for the construction workers in the Tamil Nadu Construction Workers Welfare Board. He has

reported that the said waiver is only to remove the difficulties faced by the construction workers. He has therefore requested the Government to pass appropriate orders waiving the one time registration fee of Rs.25/- and renewal fee of Rs.10/- (Once in two years).

4. Hon'ble Minister for Labour has also made an announcement in the floor of the Tamil Nadu Legislative Assembly on 12.8.2006 to dispense the one time registration fee of Rs.25/- and renewal fee of Rs.10/- collected once in two years from the construction workers.

5. The Government after careful examination, direct that the one time registration fee of Rs.25/- collected from the construction workers under Clause 5 of Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 and renewal fee of Rs.10/- collected from the registrants once in two years as per clause 6 of the Scheme, 1994 be dispensed with.

6. Notification for amending the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 will be issued separately.
