ORDER:

According to Clause 17(1) of the Tamil Nadu Construction Workers Welfare Scheme 1994, the Secretary or any other officer authorized on behalf by the Tamil Nadu Construction Workers Welfare Board, shall on an application from a registered woman manual worker, sanction a sum of Rs.4000/- (Rupees Four Thousand only) on her producing proof of either delivery of a child to her or the miscarriage of her pregnancy or the termination of her pregnancy, as ordered in the G.O.first read above.

2. The Chairman, Tamil Nadu Construction Workers Welfare Board, in his letter second read above, has sent proposal to enhance the Maternity Assistance from the existing amount of Rs.4000/- to Rs.6000/- for the Registered Construction Women Workers on par with the Agricultural Workers Welfare Board. He has also indicated that the additional financial commitment will be met from the funds of the Tamil Nadu Construction workers Welfare Board and there is no need to allot any funds from the Government.

3. The Government, after careful examination of the proposal of the Chairman, Tamil Nadu Construction Workers Welfare Board, sanction the assistance for delivery / the

miscarriage of pregnancy/the termination of pregnancy to the registered women construction workers of the Tamil Nadu Construction Workers Welfare Board with effect from 1.9.2006 as follows:-

| (b) | Miscarriage | Rs.3000/- (Rupees Three Thousand only) |
| (c) | Termination | Rs.3,000/- (Rupees Three Thousand only) |

The expenditure shall be met from the funds of Tamil Nadu Construction Workers Welfare Board.
