### ORDER :

The appended notification will be pulished in the Tamil Nadu Government Gazette both in English and Tamil.

2. The Secretary, Tamil Development and Culture (Translations) Department will furnish the Tamil version of the Notification to the Works Manager, Government Central Press, Chennai for publication in the Gazette.

3. The non-official members of the Board shall hold office for a period of 2 (two) years commencing on and from the date on which this appointment is first notified in the Tamil Nadu Government Gazette as per sub-rule (2) of Rule 19 of the Tamil Nadu Manual Workers Regulation of Employment and Conditions of Work) Rules, 1986.

4. An officer in the cadre of Joint Commissioner of Labour, Department of Labour is designated as Special Officer to over-see the Board activities.

5. The Board shall be treated as First Class Committee for the purpose of Travelling Allowance and Daily Allowance. The Special Officer of the Board is authorised to countersign the travelling allowance bills of the non-official members of the Board.

6. The expenditure shall be met from the Tamil Nadu Manual Workers Welfare Board.

7. This orders does not require the concurrence of the Finance Department vide G.O. Ms. No. 1177, Finance, dated 19.9.1973.
