ORDER :

In the G.O. first read above, draft amendment to certain Rules to the Tamil Nadu Motor Transport Workers Rules, 1965 were issued. In the Notification of the said G.O. it was also indicated therein to address the Labour and Employment Department regarding any objections and suggestions, through the Commissioner of Labour, Chennai-6. The preliminary Notification was published in Tamil Nadu Government Gazette dated 15.3.2000 in Part III Section 1(a) page 45.

APPENDIX

NOTIFICATION

In exercise of the powers conferred by sub-sections (1) and (2) of Section 40 of the Motor Transport Workers Act, 1961 (Central Act 27 of 1961), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Motor Transport Workers Rules, 1965, the same having been previously published as required by sub-section (1) of the said Section.

AMENDMENT

In the said Rules,

(1) In Rule 4, in Sub-rule (4), for the Table, the following Table shall be substituted, namely :-

THE TABLE

Maximum number of Motor Transport workers to be employed on any day during the year.	Fees in rupees.
Not more than 10	75/-
More than 10 but not more than 25	165/-
More than 25 but not more than 50	330/-
More than 50 but not more than 100	675/-
More than 100 but not more than 250	1650/-

More than 250 but not more than 500	3300/-
More than 500 but not more than 750	4950/-
More than 750 but not more than 1000	6750/-
More than 1000	10125/-

(2) in rule 7, in sub-rule (3), for the words “rupees twenty”, the words “rupees thirty” shall be substituted.

(3) in rule 9, in sub-rule (2), for the words “rupees fifteen”, the words “rupees thirty” shall be substituted.

(4) in rule 11, in sub-rule (1), for the words “rupees twenty”, the words “rupees thirty” shall be substituted.
