



## **ABSTRACT**

### **ORDER:**

In the G.O. first read above, the Government established the Tamil Nadu Artists Welfare Board with effect from 1.9.2006.

The non-official members nominated to the Board in this order shall hold office for a period of two years commencing on and from the date on which his appointment is first notified in the Tamil Nadu Government Gazette, as per sub-rule (2) of rule 19 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Rules, 1986.

8. The members shall be treated as officers of First Class Committee for the purpose of Travelling Allowance and Daily Allowance. The Chief Executive Officer/Secretary, Tamil Nadu Artists Welfare Board is authorized to countersign the T.A.Bills of these non-official members of the Board .
