ORDER:

In the G.O.Ms.No.238 , Labour and Employment dated 2.12.2003 orders were issued for establishment of 3 Government Industrial Training Institutes for women at Andipatti, Karur and Namakkal and for the establishment of exclusive women wing in the existing Industrial Training Units with the trades , units/ seats at Hosur, Thanjavur and Ramanathapuram. The Government have also sanctioned a sum of Rs.228 lakhs for purchase of equipment , furniture etc. for the new Industrial Training Institutes for women and for exclusive women wings established in the 3 Industrial Training Institutes under the head of account 4250-00-203-JR- starting of new I.T.Is and wing for women.

- 2. The Commissioner of Employment and training in his letter second cited has stated that a sum of Rs.192 lakhs has been provided in the Final Supplementary Estimate for Equipment under the head "4250-00-203-JR.19. Machinery and Equipment –01. Purchase and an amount of Rs.12.00 lakhs under 16. Major works(for power wiring). Out of the amount sanctioned for 19. Machinery and Equipment , a sum of Rs. 101.44 lakhs had been incurred and Rs.90.56 lakhs has been surrendered during 2003-04. The amount of Rs. 12.00 lakhs sanctioned under the head 16. Major works had also been surrendered . The Commissioner of Employment and Training has now requested the Government to sanction Rs.90.56 lakhs for equipment under the head 19 ,. Machinery and Equipment and Rs.12.00 lakhs for civil works under the head 16 Major works.
- 3. The Government after careful consideration, accept the proposal of the Commissioner of Employment and Training and sanction a sum of Rs. 90.56 lakhs (

Rupees ninety lakhs and fifty six thousands only) for purchase of machinery, equipment and furniture under the following head of account:-

" 4250-00-Capital Outlay on Other Social Services – 203 Employment – Schemes in the X Five Year Plan- II State Plan- JR. Starting of new I.T.Is and wing for women . 19. Machinery and Equipment – 01. Purchase

(DPC No. 4250..00..203..JR..1917.)"

The Government also sanction a sum of Rs.12 lakhs for power wiring work of the above Industrial Training Institute under the head of account:

- " 4250-00-Capital Outlay on Other Social Services 203 Employment Schemes in the X Five Year Plan- II State Plan- JR. Starting of new I.T.Is and wing for women 16. Major works (DPC No.4250-00-203-JR.1604)"
- 4. Necessary funds will be provided in RE/FMA 2004-05 . Pending provision of funds in RE/FMA 2004-05, the Commissioner of Employment and Training is permitted to incur the expenditure.
- 5. The Pay and Accounts Officer / Treasury Officer concerned is requested to admit and honour the bill if it is otherwise found in order, pending provision of funds in RE/FMA 2004-05.
- 6. The Commissioner of Employment and Training is requested to include this expenditure while sending RE/FMA 2004-05 proposal, without fail.
- 7. This order issues with the concurrence of Finance Department vide its U.O.No.54193/L&E/2004 dt.20.8.2004 and additional sanction Ledger No.513.
