ORDER:

The Director of Medical & Rural health Services (ESI) has sent necessary proposals to Government for forming Allocation committee by suggesting the names of members to be appointed to the Committee. After considering the proposals, the Government direct that the Allocation Committee be constituted as indicated in the Appendix to this order.

- 2. The Works Manager, Government Central Press, Chennai-79 shall be requested to publish the appended notification in English and Tamil. The Tamil Development Culture and Religious Endowments (Translation) Department, Chennai-9 is requested to send to the Works Manager, Government Central Press, Chennai-79 with the Tamil Translation of the notification.
- 3. The term of Office of the members will be 3 years commencing from the date on which their nomination is notified. The member shall resign his office by giving notice in writing to the State Government and the seat shall fall vacant on acceptance of the resignation. He shall cease to be member if he is absent for 3 consecutive meeting provided that his membership may be restored by Government if it is satisfied with the circumstances which led to his absence. Non-official member shall receive such fees and allowances as specified by Government from time to time. The Committee shall discharge the duties and responsibilities placed before it by the ESI Medical Benefit Rules and State ESI (Medical Benefit) Rules.

- 4. The Committee comprises, Serving Government Officials, Travelling Allowance/Dearness Allowance will be allowed as per the existing rules and no sitting fees will be allowed for the Government Officials. The Chairman of the Committee will countersign the Travelling Allowance bills of the members or Deputies.
- 5. The expenditure on account of the travelling allowance and daily allowance shall be debited to:
- " 2210 Medical and Public Health 01 Urban Health Services- Allopathy 102 ESI Scheme-I Non Plan AG Expenditure on ESI Scheme –04 Travel Expenses 01: Tour Travelling Allowance both the Insured Persons and their families".
