ORDER:

In the Government order first and second read above, the Government established Study Circles in 29 District Headquarters in order to promote and enhance the capacities of the unemployed youth to take up various competitive examinations. In the Government order third above, the Government extended the scheme to start the Study Circles in Six Panchayat Unions viz. Andipatti, Ilayankudi, Uthiramerur, Dharmapuri, Sankarankoil and Peiyakulam Panchayat Unions.

2. While moving the demand of the Labour and Employment Department on the floor of the Tamil Nadu Legislative Assembly for the year 2003-2004, the Honourable Minister for Labour has made an announcement that the Government have decided to extend the Study Circles in all the remaining 379 Panchayat Unions in the State in order to cover the unemployed youth in rural areas.

3. Accordingly, the Commissioner of Employment and Training, in his letter fifth read above, has sent necessary proposals for extension of Study Circles in 379 Panchayat Unions and requested sanction of expenditure to the tune of Rs.79.59 lakhs as detailed below:-

RECURRING:

Expenditure at the rate of Rs. 1000/- p.m. for the purchase of books, magazines, dailies etc. for 379 Study Circles.

 $(1000 \times 12 \times 379)$

.. Rs.45,48,000/-

NON RECURRING:

Purchase of Two Almirahs and Ten chairs for each Study Circle at the rate of Rs.3000/- per Almirah and 300/- per chair for 379 Study Circles

 $(3000 \times 2 \quad 300 \times 10)$

.. Rs.34,11,000/-

Total expenditure for one year (2003-04)

for 379 Study Circles in the Panchayat Unions .. Rs.79,59,000/-

- 4. The Government have examined the proposal of Commissioner of Employment and Training in para 3 above and decided to accept the proposal and issue the following orders:
- 1.During 2003-2004 the Government sanction for extension of Study Circles in all the remaining 379 Panchayat Unions in the State indicated in the Annexure to this Order and
- 2.The Government accord sanction of Rs.60,64,000/-(Rupees Sixty lakhs and sixty four thousand only) i.e. recurring expenditure of Rs. 26,53,000/-(Rupees Twenty Six lakhs and fifty three thousand only) for purchase of books, magazines dailies etc. for each of 379 Study Circles for Seven months from September 2003 to March 2004 and non-recurring expenditure of Rs.34,11,0000/-(Rupees Thirty four lakhs and eleven thousand only) for purchase of furniture as indicated in para 3 above for each of the 379 Panchayat Unions in the State indicated in the Annexure to this order.
- 5. The expenditure sanctioned in paragraph 4 above, shall be debited under the following head of account:
- "2230- Labour and Employment-02.Employment-101.Employment Services –I Non-Plan AA. District Employment Staff -72 Training"

6. The Government direct that the purchase of Two(2) Almirahs and Ten (10) Chairs for each Study Circle shall be made at the level of District Collector concerned and the bills of cost may be settled by the Assistant Director/District Employment Officer

concerned as soon as they are received in the respective Panchayat Unions. The Government also direct that the books, magazines, dailies etc. shall be purchased by the Assistant Director/District Employment Officer concerned according to the needs of the Study Circle, based on the list of books/magazines purchased for the District Employment Office. In case of purchase of other books not found in the approved list, the approval of Commissioner of Employment and Training should be obtained and purchase can be made only after approval. Proper accounts should be maintained by each Study Circle following the office procedures in force and the Revenue collected for disposal of old magazine/dailies should be remitted to the Government in the following head of account:

"0230.00- Labour and Employment -800.Other receipts – AF. Other receipts-02.Other Items"

7.In the Govt. Letter seventh read above, the District Collectors have been requested to provide a room in each Panchayat Union if available in Arivoli Iyakkam building or in the Local Library or in a Local School Building along with one staff from each Panchayat Union for monitoring the Study Circles. The District Collectors have also been requested to issue suitable instructions to all concerned for provision of room either in the Arivoli Iyakkam building/School Building/Local Library, as the case may be and also to spare the services of Rural Welfare Officer for supervising the Study Circles.

- 8. The expenditure is on a "New instrument of service" and the approval of the Legislature will be obtained in due course. Until the approval of this legislature is obtained the expenditure will be met by an advance from the contingency fund. Appropriate order will be issue in this regard in Finance (Budget-I) Department. The Commissioner of Employment and Training shall apply in the prescribed format to the Finance Department for the expenditure to be incurred by getting advance from the Contingency Fund for the year 2003-2004.
- 9. Necessary funds will be provided in Revised Estimate / Final Modification of Appropriation 2003-2004. Pending provision of funds in Revised Estimate/Final Modification of Appropriation 2003-2004, the Treasury Officers are instructed to admit the claim as and when presented by the District Employment Officers concerned if it is found otherwise in order. The Commissioner of Employment and Training, Chennai-5 is requested to include this expenditure while sending necessary budget proposals for Revised Estimate/Final Modification of Appropriation 2003-2004 to the Government in Finance Department without fail.
- 10. The Commissioner of Employment and Training is requested to examine the possibilities for integration of the Study Circles with the Rural Libraries, in consultation with the Director of Public Libraries under the District Library Movement from the next financial year 2004-2005 and send his report to the Government in due course.
