In the Government Order second read above, the Government have constituted the State Child Labour Rehabilitation-cum-Welfare Society under the Chairmanship of the Commissioner of Labour, exempting it from the provisions of Sec.15(3)(4) of the Tamil Nadu Societies Registration Act, 1975 and Rule 45 of the Tamil Nadu Societies Registration Rules, 1978 to register the above society under the Tamil Nadu Societies Registration Act, 1975.
- 3.In the Government order third read above, the Government have approved the Memorandum of Association and Bye-Laws of the State Child Labour Rehabilitation-cum-Welfare Society. Accordingly, the society will have 17 members, of whom 13 will be officials of the State Government. The Commissioner of Labour, in his Demi-Official letter fourth read above has requested the orders of the Government for nomination of four Non-Official Members of the above society.
