- (2) Notice is hereby given that the draft amendment will be taken into consideration on or after the expiry of three months from the date of publication of this Notification in the Tamil Nadu Government Gazette and that any objection or suggestion which may be received from any person with respect thereto before the expiry of the aforesaid period will be conisdered by the Government of Tamil Nadu. DRAFT AMENDMENT

In the said Rules for the proviso to sub-rule 4 of rule 21, the following proviso shall be substituted, namely:-

" Provided that no annual return in Form III need be sent by an employer, if a combined annual return in Form No.22 as required in clause (2) of rules 100 of the Tamil Nadu Factrories Rules, 1950 is furnished."
