**NOTIFICATION**  
**New Delhi, the 18th May, 2001.**

G.S.R.375 (E):- In exercise of the powers conferred by Sub-section (1) of the Section 37 of the Apprentices Act, 1961 (52 of 1961) and after consulting the Central Apprenticeship Council, the Central Government hereby makes the following rules further to amend the Apprenticeship Rules, 1992, namely:-

1. (1) These rules may be called the Apprenticeship (Amendment) Rules, 2001.  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Apprenticeship Rules, 1992 in rule 11, and sub-rule (2) for clauses (a), (b), (c), (d) and (e) and entries relating thereto, the following shall be substituted, namely:
  - (a) Engineering Grades (for post-institutional training) Rs.1,970/- per month
  - (b) Sandwich Course (students from Degree Institutions) Rs.1,400/- per month
  - (c) Diploma Holders (for post-institutional training) Rs.1,400/- per month
  - (d) Sandwich course (students from Diploca Institutions) Rs.1,140/- per month
  - (e) Vocational Certificate Holders Rs.1,090/- per month
