In the G.O. first read above, a preliminary Notification containing the draft proposal for amalgamation of nine Welfare Boards with the Tamil Nadu Manual Workers Social Security Welfare Board was published in the Tamil Nadu Government Gazette, Extraordinary dated 17.12.2003 and objections and suggestions were invited from the persons likely to be affected. NOTIFICATION.

In exercise of the powers conferred by sub-section (1) and sub-section(3) of section 6-A of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu hereby approves the proposal for amalgamation of the following nine Boards with Tamil Nadu Manual Workers Social Security and Welfare Board, the draft of the same having been previously published in the Tamil Nadu Government Gazette, and Tamil Daily, as required by sub-section (1) of section 6-A of the Said Act:-

The Tamil Nadu Auto Rickshaws and Taxi Drivers Welfare Board.

The Tamil Nadu Washermen Welfare Board.

The Tamil Nadu Hair Dressers Welfare Board.

The Tamil Nadu Tailoring Workers Welfare Board.

The Tamil Nadu Palm Tree Workers Welfare Board.

The Tamil Nadu Handicraft Workers Welfare Board.

The Tamil Nadu Hanloom and Handloom Silk Weaving Workers Welfare Board.

The Tamil Nadu Footwear and Leather goods Manufactory and Tannery Workers Welfare Board.

The Tamil Nadu Artists Welfare Board.

- 2. This Notification shall come into force with effect on and from the date of its publication in the **Tamil Nadu Government Gazette.**
- 3. The constitution and authorities of the Tamil Nadu Manual Workers Social Security and Welfare Board and the duties and liabilities and obligations of the said Board shall be the same on the date of order of amalgamation and the Board shall also consist of such members nominated from time to time by the Government representing the employers, the manual workers and the Government.
- 4. Every manual worker registered, the contribution made by any manual worker and the contribution made by any employer and the consequential benefits accrued to any manual worker under the Tamil Nadu Tailoring Workers Social Security and Welfare Scheme, 2001, Tamil Nadu Autorickshaw and Taxi Drivers Social Security and Welfare Scheme, 2001, Tamil Nadu Washermen Social Security and Welfare Scheme, 2001, Tamil Nadu Hair Dressers Social Security and Welfare Scheme, 2001, Tamil Nadu Handicraft

Workers Social Security and Welfare Scheme, 2001, Tamil Nadu Palm Tree Workers Social Security and Welfare Scheme, 2001 shall be construed as the registration made, contribution made and the benefits accrued under the Tamil Nadu Manual Workers Social Security and Welfare Scheme, 2001.

5. On and from the date of order of amalgamation, the assets, the liabilities, properties, rights and interests and the records, registers and other documents of the Boards so amalgamated shall stand transferred to the Tamil Nadu Manual Workers Social Security and Welfare Board.
