### **ORDER**

In the Government Order first read above, a draft preliminary notification containing amendments to rules 24(1), 26(2) and 30 of the Tamil Nadu Contract Labour (Regulation and Abolition) Rules, 1975 for revision of fees for grant or renewal of licence and security deposit was issued and objections and suggestions were invited from the persons likely to be affected by such revision.

2. The Commissioner of Labour in his letter second read above has reported that no objection or suggestion with regard to the draft preliminary Notification has been received so far. He has, therefore, proposed that the draft notification issued in the Government Order first read above may be confirmed.

Subsequently, it has been decided that rule 29(3) of the said rules may also be amended and according by the Commissioner of Labour has sent revised draft preliminary Notification amending rule 24(1) 26(2), and 29(3) and 30 of the Tamil Nadu Contract Labour (Regulation and Abolition) Rules, 1975. The Government have, therefore decided ,to issue fresh preliminary Notification by superceding the earlier preliminary Notification issued in the G.O.first read above.

3. The Notification appended to this order will be published in the Tamil Nadu Government Gazette both in English and Tamil. The Secretary to Government, Tamil Development and Culture and Religious Endowments (Translation) Department,
