## **APPENDIX**

### **NOTIFICATION**

In exercise of the powers conferred by section 30 the Minimum Wages Act, 1948 (Central Act XI of 1948) the Governor of Tamil Nadu hereby makes the following amendment to the Minimum Wages (Tamil Nadu) Rules 1953 the draft of the same having been previously published as required by sub-section (1) of the section 30 of the said Act.

### **AMENDMENT**

In the said Rules, in rule 21, for the proviso to sub-rule 4, the following proviso shall be substituted, namely:-

“ Provided that no annual return in Form III need be sent by an employer, if a combined annual return in Form No.22 as required in clause (2) of rule 100 of the Tamil Nadu Factories Rules, 1950 is furnished. “
