**APPENDIX**

**NOTIFICATION**

In exercise of the powers conferred by Section 29 of the Tamil Nadu Catering Establishments Act, 1958 (Tamil Nadu Act XIII of 1958), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Catering Establishments Rules, 1959.

2. The amendments hereby made shall come into force with effect on and from the date of publication.

**AMENDMENTS**

In the said Rules, --

(1) in rule 3, in sub-rule (2), for the Table, the following Table shall be substituted, namely

**“THE TABLE**

If the number of employees proposed to be employed on any day during the calendar year to which the registration relates : -

	Fees
	Rs. P .
does not exceed 5	45.00
exceeds 5 but does not exceed 10	90.00
exceeds 10 but does not exceed 20	180.00
exceeds 20 but does not exceed 50	450.00
exceeds 50 but does not exceed 100	900.00
exceeds 100	2250.00

(2) in rule 5-A, in sub-rule (3), for the words “rupees twenty” the words “rupees thirty” shall be substituted;

(3) in rule 6-A, in sub-rule (2), for the words “rupees ten”, the words “rupees fifteen” shall be substituted;

(4) in rule 7, in sub rule(1), for the word “rupees ten,” the words “rupees fifteen” shall be substituted.
