While moving the Demand No.31, Labour and Employment Department 2002-2003, the Hon’ble Minister for Labour has made the following announcement:-

“Job portal at Directorate of Employment and Training to encourage private placement, on On-line interactive Web-site-cum-portal will be set up to develop a data bank of highly qualified, marketable candidates from the Live Registers of the Employment Exchanges in Tamil Nadu to allow private sector employers and others for easy access to this data”.

2. Based on the above announcement, the Director of Employment and Training has sent proposals for the setting up of an “On-line interactive Web-site-cum-portal for his Directorate.

3. The object of the above proposal is enumerated below:-

1. 1) To develop a Data Bank of highly qualified, marketable candidates from the Live Register of the Employment Exchanges in Tamil Nadu with the accent on persons with professional executive and engineering diploma and degrees.
2. 2) To allow the private sector employers easy access to this data base to fill up vacancies arising in their establishments and to offer facilities for screening and short-listing of prospective employees.
3. 3) To provide on line interactive vocational guidance and expertise both in house and outside, on career guidance, group discussions, competitive examinations, interview techniques, aptitude testing and related topics.
4. 4) To Provide on line information on application dead lines, hot track careers and future trends in employment.

5. 5) To set up a Virtual coaching class for students taking up competitive examinations from +2 level to Junior Research Fellowship examinations.
6. 6) To Provide for on line registration in future.
7. 7) To make the Web site self sustaining by allowing advertisement on the site.
8. 8) To hest chat shows on all topics on Human Research Development.
9. 9) To promote E-groups on these subjects to enhance the quality of services provided.
10. 10) To publish on the net information on the seniority of registration up to which candidates are sponsored against vacancies in the Employment Exchanges.

3. In his proposal the Director of Employment and Training and proposed to have 2 dedicated web cum data base servers one at N.I.C. premises and one at the premises of his Directorate. The Web server to be located in N.I.C. premises will be without any expenditure on infrastructure and applications development will be done free of cost by N.I.C.

4. The Director of Employment and Training has also furnished the details of expenditure for setting up an on line interactive web site-cum-portal as indicated below:-
