ORDER

In the Government Order first read above, the minimum rates of wages for employment in Construction or maintenance of roads or in building operations were last revised under the provisions of the Minimum Wages Act, 1948. The Government have now proposed to further revise these minimum rates of wages to the employment in Construction or maintenance or roads or in building operations.

2. The appended Notification will accordingly be published in the Tamil Nadu Government Gazette both in English and Tamil. DRAFT NOTIFICATION

In exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in supersession of the Labour and Employment Department Notification No. II (2)/LE/576/2000, dated the 24th April, 2000, published at page 273 and 274 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 31st May 2000, the Governor of Tamil Nadu hereby revises the minimum rates of wages payable to the classes of employees in the employment in Construction or Maintenance of Roads or in Building Operations in the State of Tamil Nadu specified in column (1) of the Schedule below, as specified in the corresponding entries in column (2) thereof:

Explanations:-

(1) Composition of Zones is as follows:-

Zone-A:- All Corporations and all hill stations as detailed below including works lying in the Reserve Forest areas and 5 Kilometers belt areas.

Hill Stations:-

- 1. (1) The Nilgiris Plateau
- 2. (2) Valparai sub-taluk of Coimbatore District
- 3. (3) The Shevroys
- 4. (4) Kodaikanal
- 5. (5) Peermedu
- 6. (6) Sangalteri in the Kalakkad reserve of Nanguneri range in Tirunelveli District.
- 7. (7) Mudaliaroothu in the Srivilliputhur reserve of Srivilliputhur range in Virudhunagar District.
- 8. (8) Gudalur Taluk in the Nilgiris District
- 9. (9) Javadi Hills and Elagiri Hills in the Vellore District

Zone-B:- All types of Municipalities and Townships.

Zone-C:- All other areas in the State not covered in Zones 'A' and 'B' above.

- (2) Classification of employees into Class-I and Class-II is based on Physical capacity, skill, efficiency and out-turn of work.
- (3) In case of piece rated workers, their daily total earning for 8 hours of work shall not be less than the daily rates of wages revised for that category of employees. In computing the above rates, a day's work is deemed to comprise of 8 working hours. If the employee is employed for less than 8 hours, wages have to be calculated proportionately.

(4) Others:-(1) In addition to the minimum wages fixed above, the employees shall be paid dearness allowance as indicated below:-

Dearness Allowance:-

- (i) The dearness allowance is linked to the Average Chennai City Consumer Price Index Number for the year, 2000 (that is, 475 points with base 1982=100) and for every rise of one point over and above 475 points 24 paise (twenty four paise) per day shall be paid as dearness allowance.
 - 1. (ii) The dearness allowance shall be calculated every year on the first April on the basis of the average of the indices for the proceeding 12 months, namely, from January to December.
 - 2. (iii) The first calculation shall thus be effective from the date of publication of this Notification in the Tamil Nadu Government Gazette based on the Average Consumer Price Index of the previous year.
- 2) Where the nature of work is the same, no distinction in the payment of wages shall be made in the case of men and women workers.
- (3) To arrive at the daily wages, the monthly wages shall be divided by 26.
- (4) To arrive at the monthly wages, the daily wages shall be multiplied by 30.
- (5) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
