ORDER :

In the G.O. first read above, orders were issued permitting to start private Industrial Training Institutes under National Council for Vocational Training pattern in 218 Panchayat Unions where there were no Industrial Training Institutes within three years from 1997.

2. In the G.O. third read above , orders were issued for the following 3 categories for August 2001 academic year only to start private Industrial Training Institutes in 79 uncovered Panchayat Unions to those who come on voluntary basis:-

1. 1) Without making advertisement , those private agencies willing to start new Industrial Training centers in uncovered Panchayat Unions, may be inspected and recommend to central Government .
2. 2) Those Management administering the Engineering colleges/ polytechnics and willing to start new Industrial Training centers in their campus, may be given permission to start Industrial Training Centres.
3. 3) Those industries willing to start new Industrial Training Institutes for training their employees and to cater their needs.

3. The Director of Employment and Training in his letter fourth read above, has now requested to include the following additional category without making advertisement in dailies for starting of private Industrial Training Institutes under National Council for Vocational Training pattern, if the private agencies come on voluntary basis and inspection may be carried out for considering grant of affiliation:-

“ Those management willing to start new Industrial Training Centers, with trades of modern and updated technology like Information Technology and Electronic System Maintenance, Computer Hardware, Medical Electronics consumer Electronics, Industrial Electronics and any multi-skill trades”.

4. He has also stated that the private managements are providing necessary funds for starting new Industrial Training Centers / Industrial Training Institutes which satisfy the National Council for Vocational Training norms alone will be recommended for affiliation .

5. After careful examination , the Government decided to accept the proposal of Director of Employment and Training and accordingly the Government permit the Director of Employment and Training to accord permission for starting private Industrial Training Institutes as per National Council for Vocational Training norms in respect of following categories for the year 2002-2003 (academic year) without publishing advertisement in dailies .

1. 1) Those Management willing to start new private Industrial Training Centers in uncovered 79 Panchayat Unions;
2. 2) Those Managements administering Engineering Colleges/ Polytechnics and willing to start new private Industrial Training Centers in their campus,
3. 3) Those industries willing to start new Private Industrial Training Centers for training their own employees to cater to their needs,
4. 4) Those managements willing to start new Industrial Training Centers with trades of modern and updated Technology like Information Technology and Electronic System Maintenance, Computer Hardware, Medical Electronics, consumer Electronics, Industrial Electronics and any multi-skill trades and allow them to start Industrial Training Institutes anywhere in Tamil Nadu.
