**APPENDIX** 

**NOTIFICATION** 

In exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in super session of the Labour and Employment Department Notification No.II (2)/LE/1933(a)/98, Published at page 1 and 2 of the Part II- Section 2 of the Tamil Nadu Government Gazette, Extraordinary, dated the 4th November, 1998, the Governor of Tamil Nadu hereby revises the minimum rates of wages payable to the employees engaged in the classes of work in Tobacco (Beedi Rolling) Manufactory in the State of Tamil Nadu specified in column (1) of the Schedule below, as specified in the corresponding entries in column (2) thereof, the draft of the same having been previously published as required by clause (b) of sub-section (1) of section 5 of the said Act

2. This Notification shall come into force on and from the date of its publication in the Tamil Nadu Government Gazette.

# **EXPLANATIONS**;-

- (1) The above rates are exclusive of the payment, if any, being made by way of bonus.
- 2) Dearness Allowance: (i) Dearness Allowance for beedi rolling is linked to 1301 points that is the average Chennai City Consumer Price Index Number for the year 1993 (with base 1960=100) and for any future rise of every point over and above 1301 points, an increase of 2(two) paise per 1000 beedies shall be paid as dearness allowance.
- ii) The Dearness Allowance shall be calculated every year on the 1st April, on the basis of the average of the indices for the preceding 12 months, namely from January to December.
- iii) The first calculation shall thus be made effective from the date of publication of this Notification in the Tamil Nadu Government Gazette, based on the average of Consumer Price Index of the previous year.

- 3) Wherever the existing wages are higher than the minimum wages fixed herein, the same existing wages shall be continued to be paid.
- 4) No distinction in the payment of wages shall be made in the case of men and women workers.
