ORDER:

The Integrated Housing Scheme for Beedi Workers is implemented in this State with Central Government subsidy of Rs. 20,000/- and the State subsidy of Rs. 5,000/- per house. The Ministry of Labour, Government of India in their letters first and third second read above have granted administrative approval for construction of a total number of 1285 houses. Out of which the State Government have already released State subsidy of Rs. 18.75 lakhs for construction of 375 houses at the rate of Rs. 5,000/- per house vide Government Order second read above.

2. The Commissioner of Labour in his letter fourth read above has submitted the proposals for sanction of Rs.6,20,000/- for construction of another 124 houses for Beedi Workers from out of the 1285 houses for which Government of India has accorded approval as detailed below:-
