In exercise of the powers conferred by sub/section (1) of section 43 of the Plantations Labour Act, 1951 (Central Act LXIX of 1951) and in supersession of the Labour and Employment Department Notification No. S.R.O. A-5/97 dated the 30th October 1996 published at page 6 of Part-III Section 1(a) of the Tamil Nadu Government Gazette dated the 8th January 1997, is hereby published as required by the said sub-section (1), after subjecting the same to the previous approval of the Central Government as required by sub-section (3) of section 43 of the said Act.
