## ORDER:

While moving the demands of the Labour and Employment Department, on the Floor of the Assembly for the year 2002-2003, the Honourable Minister for Labour has made an announcement that the Government have decided to extend study circles in 6 Panchayat Unions viz. Andipatti/Illayankudi/Uthiramerur/Dharmapuri/Sankarankoil and Periyakulam to Promote and enhance the capacities of the unemployed youth to take up various competitive examinations. Based on the above announcement, the Director of Employment and Training has submitted proposals for extension of the study circles for the above 6 Panchayat Unions, along with the statement of expenditure involved with the Government.
2. At present, study circles were established in 29 District headquarters by Government under G.O.Ms.No.106, Labour and Employment Department, Dated: 20.7.99 and G.O.Ms. No. 138, Labour and Employment Department, Dated: 4.10.2001 to promote and enhance the capacities of the unemployed youth to take up various competitive examinations. It is necessary to set up more study circles to reach the benefits of the scheme to more areas. Accordingly, the 6 study circles will be extended to 6 Panchayat Unions viz.

Andipatti/Illayankudi/Uthiramerur/Dharmapuri/Sankarankoil and Periyakulam. The Director of Employment and Training and furnished the expenditure for the extension of the 6 study circles as detailed below:-

3. The proposal of the Director of Employment and Training in para 2 above has been carefully examined by the Government and decided to accept the proposal and issue the following orders :

1. As a first step, during the year 2002-03, the Government sanction for the extension of the Study circles to 6 Panchayat Unions at Andipatti/ Ilayankudi/ Uthiramerur/ Dharmapuri/Sankarankoil and Periyakulam:
2. The Government accord sanction of Rs. 1,26,000/- i.e. recurring expenditure of Rs.72,000/- and a non-recurring expenditure of Rs. 54,000/- for the above scheme as indicated at para 2 above.
4.The expenditure sanctioned in para 3 above shall be debited under the following head of account.
"2230-Labour and Employment-02-Employment-101-Employment Services-I-Non-Plan-AA-District Employment Office-72 Training.
3. Necessary funds will be provided in RE/FMA 2002-03, pending provision of funds in RE/FMA 2002-2003, the Treasury Officers are instructed to admit the claim as and when presented by the District Employment Officers concerned if it is found otherwise in order. The Director of Employment and Training, Chennai-5 is requested to include this expenditure while sending necessary budget proposals for RE/FMA to the Government in Finance Department without fail.
4. The books/periodicals and newspapers purchased for the study circles should be properly accounted for. The revenue from the disposal of old newspapers/periodicals should be credited to the following head of account:-
