### **ORDER**

In supersession of the Government orders read above and all orders and instructions on the subject, the Government after careful consideration hereby order that for filling up any vacancy in any employment in Government Departments, in Public Sector and all Government aided institutions, wherever any vacancy has to be filled by candidates sponsored by Employment Exchange, directions specified hereunder shall be followed:-

1. (a) for the vacancies notified by the Teachers recruitments Board, vacancies of Junior Training Officers in Industrial Training Institutes,

vacancies in Secondary Grade Teachers, vacancies in local bodies in urban areas, vacancies in local bodies in rural areas and vacancies in co-operative institutions, Employment Exchanges shall sponsor candidates in the ratio of 1:10.

- 2. (b) so far as the vacancies in the Government aided Engineering Colleges and Polytechnics, the said ratio shall be 1: 30; and
- 3. (c) in all cases other those specified in items(a)and (b) above such ratio shall be 1:20
- 2) The authority making the selection for appointment shall consider the merit of all the candidates sponsored by the Employment Exchanges and the selection shall be made based on merit and not based on seniority of registration in the Employment Exchanges ONLY.
