ORDER:

As per the orders issued in G.O.Ms.no 49, Labour and Employment Department dated 30.3.95, Government ITI, Neeadangalam was started 7th August 1995 with the following trades in a private rented building at Needamangalam, Tiruvarur District.

- 2. The private building in which the ITI is now functioning is not having the adequate space as per NCVT norms and basic amenities. A sum of Rs.0.95 lakhs per annum is paid as rent to the private building.
- 3. There is persistent demand from the trainees for the provision of basic amenities could not be provided as the ITI is functioning in a private building. The owner of the building is reluctant to undertake any civil work not only for want of adequate space to carry out any additional civil work but also of the fact that the ITI is functioning temporarily in the private building and it could be vacated any time. For want of space as per NCVT norms, permanent affiliation could not be obtained for this ITI. Now, Government in G.O.No.996, Revenue Department, dated 22/12/98, have allotted 3.25 hectares of land in Survey No.140/2 in 2 Nagar Village, Needamangalam Taluk, Thiruvrur District. The land is found to be suitable for the construction of own building to Government ITI, Needamangalam
- 4.It is essential that the ITI should have the workshop classrooms and other basic amenities as per the norms prescribed by the NCVT. The present rental building does not satisfy the NCVT stipulations. So, the constructions of own building for the ITI is absolutely necessary.
- 5.The Commissioner of Employment nd Training has now sent a proposal under Part II Scheme for 2003-04 for construction of own building for Government ITI, Needamangalam, Thiruvarur District at an ultimate cost of Rs.142.00 lakhs.
- 6.The Government after careful consideration accept the proposal of the Commissioner of Employment and Training, Chennai-5 under Part II Scheme 2003-04 for the construction of own building for Government ITI, Needamgalam, Thiruvarur district at An ultimate cost of Rs.142 lakhs and sanction a sum of Rs.10 lakhs (Rupees ten lakhs only) during the year 2003-04.
- 7. The expenditure we sanctioned in para 6 above shall be debited to the following head of account:-
- "4250 Capital outlay on other social services 203 Employment Schemes in the Tenth Five Year Plan II State Plan JG Development of Industrial Training Institutes lands buildings 16 Major works

(DPC 4250 -00-203-JG-1606)".
