ORDER:

There is a rapid growth of Information Technology in Tamil Nadu. If all The offices are brought under Computer Network making use of the Internet facilities, quick exchange of data will be ensured by having hook up facilities with Regional Offices and other subordinate offices. Almost all private establishments, quasi Government Departments, Central Government Offices and some of the State Government Departments have already been computerized.

2.In the training wing of Commissioner of Employment and Training, there are 53 Government it is, 5 Regional Offices and 14 other offices besides the Headquarters. In pursuance of G.O. No.467, Labour and Employment Department, dated 18.6.2002, computerization of Government activities, the meeting of the I.T. task force Committee held on 11.7.2002 under the Chairmanship of the Secretary to Government, Labour and Employment Department among others decided to conduct a system study of training wing by one of the approved agencies. Accordingly, the system study was undertaken by NIC, Chennai-5 and submitted its report in letter dated 21.10.2002. The report suggest for Computerisation of all offices in two phases viz., the Headquarters and Regional offices in the first phase and all unit offices in the second phase. The report has taken into account of the existing infrastructure and suggested a list of further computer hardware and software requirements. However, the computerization of the Headquarters may be taken up first.

3.The cost of providing the additional infrastructure required for computerization of the Headquarters may be restricted to Rs.5 lakhs viz., recurring Rs.0.13 lakhs and non-recurring Rs.4.87 lakhs. The expenditure may be sanction under Part II 2003-2004.

4.The Commissioner of Employment and Training has now sent a proposal under Part II Scheme for 2003-2004, for provision of Computer with Accessories with Internet facility to Head Office at an ultimate cost of Rs.5.00 lakhs.

5.The Government after careful consideration, accept the [proposal of the Commissioner of Employment and Training, under Part II Scheme 2003-04 for provision of Computer with Accessories with Internet facility to office of Commissioner of Employment and Training and sanction a sum of Rs.5.00 lakhs (Rupees five lakhs only) during the year 2003-04.

6.The expenditure sanctioned in para 5 above, shall be debited to the following head of Account.
