## ORDER:

Government I.T.I, Tiruvannamalai had been functioning in an area of 16.56.6 Hectare (41 acres). The Institute is having a strength of 272 trainees. Besides, the administrative building and workshop, the ITI had hostel and staff quarters inside the campus. But consequent on the formation of Collector's Complex and construction of Collectorate, Government in G.O.Ms.No.600, Revenue Department dt. 14.7.98 issued orders for the take over of 27.5 acres of land belonged to the ITI, leaving 13.5 acres only to the ITI with its administrative building and workshop. Owing to the takeover of ITI land, the hostel of the Institute and staff quarter s in the land were taken over by the revenue authorities. The students and the staff of the Institute were asked to vacate the authorities. The Government in the G.O.Ms.No.600, Revenue dated 14.7.98 have permitted the Department of Labour and Employment for the construction of hostel and staff quarters for the one taken over by the revenue authorities.

2. Now, the trainees of the ITI are not having hostel facilities. Adequate building is also not available for tent. So, the trainees coming from distant places find it very difficult to complete training. The ITI is nearly 5 kms away from the town. Considerable number of trainees are coming from distant villages and even from other districts. Trainees coming from distant places find their own accommodation with great difficulty. An average of 100 trainees of the Institute opt for hostel. So, the construction of hostel to the trainees of the ITI is very essential.

- 3. So, an hostel with provision for 60 trainees may be constructed in Government ITI, Tiruvannamali in the land available. Hence, an ultimate cost of Rs.40 lakhs and Rs.7 lakhs for the year 2003-04 may be sanctioned under Part II Scheme.
- 4. The Commissioner of Employment and Training has now sent a proposal under Part II Scheme for 2003-04, for construction of Hostel for Government ITI, Tiruyannamali at an ultimate coast of Rs.40 lakhs.
- 5. The Government after careful consideration, accept the proposal of the Commissioner of Employment and Training under Part II Scheme 2003-04 for construction of Hostel for Government ITI Tiruvannamali with an ultimate cost of Rs.40 lakhs (Rupees forty lakhs) and sanction is accorded for a sum of Rs.7 lakhs (Rupees seven lakhs) for the year 2003-04.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account;-
