The Chief Inspector of Factories has submitted a proposal for purchase of 5 Nos. of "Safety Kit" for the use of Inspecting Officers attached to the regular division of the Deputy Chief Inspector of Factories at an ultimate cost of Rs. 10.00 Lakhs (non-recurring expenditure) under Part II Scheme for 2005-2006.

After careful examination, the Government accept the proposal of Chief Inspector of Factories and accordingly sanction a sum of Rs. 10.00 lakhs (Rupees Ten lakhs only) as non-recurring expenditure for purchase of 5 Nos. of "Safety Kit" for the use of Inspecting Officers attached to the regular division of the Deputy Chief Inspector of Factories under Part II Scheme for the Financial Year 2005-2006
