

Employees' State Insurance Scheme - Upgrading Employees' State Insurance Dispensary at Sriperumpudur from one Doctor type to three Doctor type - Sanction - Orders - Issued.

READ:-

From the Director of Medical & Rural Health Services (ESI), letter No.7788/ESI/P1/08, dated 20.3.2008 and dated 2.7.2008.

ORDER:-

The Director of Medical and Rural Health Services (ESI) in her letter read above, has reported that one Doctor type Employees' State Insurance Dispensary is functioning at Sriperumpudur, Kancheepuram District to cater to the Medical needs of 3000 Insured Persons and their family members. It is functioning from 1.8.2005 with one Assistant Surgeon, one Nurse, one Junior Assistant, one Pharmacist, one Nursing Assistant Grade-II and two class IV staff. She reported that at present, 9496 employees are enrolled and that the Employees State Insurance Corporation has also emphasizing to increase the facilities at Employees State Insurance Dispensary, Sriperumpudur. She further stated that as per Employees State Insurance norms, for more than 5000 insured persons, a three Doctor Type Employees State Insurance Dispensary should be started. She further stated that as 9496 employees are enrolled at present, the existing one Doctor Type Employees State Insurance Dispensary, cannot provide reasonable Medical care to the above employees and their families and therefore it is highly necessary to upgrade the Employees State Insurance Dispensary, Sriperumpudur from one Doctor type to three Doctor type.

- 2.The Director of Medical and Rural Health Services (ESI) has further stated that even though the Employees State Insurance Dispensary, Harbour is functioning with three Doctors, two Assistants, two Nurses, four Pharmacists, three Nursing Assistants, eight class IV staff and one Junior Assistant, the insured persons registered is less than 1500 and the daily attendance is less than 50 and therefore she suggested that the excess posts from the Employees State Insurance Dispensary, Harbour may be redeployed to Employees State Insurance Dispensary, Sriperumpudur to be upgraded as three Doctor type Employees State Insurance Dispensary and informed that concurrence of the Employees State Insurance Corporation is not necessary for this and has sent proposals for the upgradation.
- 3. After detailed examination, the Government has accepted the proposal and accord sanction for the upgradation of the Employees State Insurance Dispensary, Sriperumpudur from one Doctor Type to three Doctors type with the following additional staff:-

Doctors - 2 Posts
 Assistant - 1 Post

3. Nurse - 1 Post
4. Pharmacist - 2 Posts
5. Nursing Asst. - 1 Post
6. Last Grade - 4 Posts
11 Posts

- 4. The staff sanctioned above shall be posted on redeployment basis from the surplus staff identified within the Employees' State Insurance Dispensary, Harbour. The Director of Medical and Rural Health Services (ESI) is requested to transfer the required furniture from the Employees State Insurance Dispensary, Harbour to Employees State Insurance Dispensary, Sriperumpudur. The upgraded Employees State Insurance Dispensary will function in the existing rented building. After formation of the upgraded Employees State Insurance Dispensary at Sriperumpudur, the present Employees State Insurance Dispensary, Harbour shall function at the existing ground floor only.
- 5. The additional posts will be redeployed from the Employees State Insurance Dispensary, Harbour to Employees State Insurance Dispensary, Sripurumpudur. The Director of Medical and Rural Health Services (ESI) is instructed to fill up these posts immediately. Necessary cadre entries shall be made in the Dispensaries and the Directorate.
