ORDER:

The Hon'ble Minister for Labour while moving Demand for the year 2009-2010, on the floor of Assembly on 9.7.2009 has made an announcement that for the benefit of employees, Employees State Insurance Scheme will be extended to Kundrathur and Mangadu area by attaching to the existing Employees State Insurance Dispensary with the concurrence of Employees State Insurance Corporation.

- 2. In the letter read above, the Director of Medical and Rural Health Services (ESIS), has sent the proposal for implementation of Employees State Insurance Scheme in Kundrathur & Mangadu area, Sriperumbudhur Taluk, Kancheepuram District by attachment with the existing Employees State Insurance Dispensary, Poonamallee, Chennai District.
- 3. The Government after careful examination, accept the proposal of the Director of Medical and Rural Health Services (ESIS) and sanction the implementation of Employees State Insurance Scheme to Kundrathur & Mangadu area, Sriperumbudhur Taluk, Kancheepuram District by attaching 1618 employees with the existing Employees State Insurance dispensary at, Poonamallee, Chennai District.
- 4. Sanction is also accorded for incurring a recurring expenditure of Rs.7,28,100/- (Rupees seven lakhs twenty eight thousand and one hundred

only) towards provision of medicine to 1618 employees and their family members.

- 5. The facilities like specialist treatment, hospitalization, laboratory test, X-ray etc., would be made available by way of referring the beneficiaries to the ESI Hospital, Ayanavaram, Chennai 23 and Kilpauk Medical College Hospital, Chennai-10.
 - 6. The expenditure shall be debited to the following head of account:-
 - "2210 Medical and Public Health-01 Urban Health Services-Allopathy-102 Employees State Insurance Schemes.I Non-Plan AG-Expenditure on ESI Scheme- Both Insured persons and their families-66 Medicine ".

(D.P.C.2210-01-102-AG-6605).

- 7. The expenditure sanctioned in para 4 shall constitute an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature the expenditure may initially be met from an advance drawing from Contingency Fund regarding which, orders will be issued separately in Finance(BG II) department. The Director of Medical and Rural Health Services(ESIS) is requested to apply for sanction of Contingency Fund in the prescribed format along with the copy of this order to Government in Finance (BG II) department and to send necessary proposal for Supplementary Estimates for inclusion of this expenditure in the Supplementary Estimates for 2010-11 to Government without fail.
- 8. The expenditure will be initially incurred by the State Government out of Budgetary support 2010-2011 and fully reimbursed from the Employees State Insurance Corporation for the first three year period, from the date of implementation of Employees State Insurance Scheme in the above area and thereafter, the expenditure shall be shared between the Employees State Insurance Corporation and the State Government in the agreed ratio of 7:1.
- 9. The formal Notification under Section 1(3) of the Employees State Insurance Act, 1948, fixing the date from which the medical facilities shall be extended to the Insured Persons and their families in the above area will be issued by the Central Government.
- 10. The Director of Medical and Rural Health Services(ESIS) shall suggest immediately a suitable date for the extension of the Employees State Insurance Scheme to the above area after making all the medical

arrangements in the said dispensary in consultation with the Regional Director, Employees State Insurance Corporation, Chennai.
