ORDER:

In the G.O. first read above the Government have sanctioned as Grant for a sum of Rs.10.00 Crores (Rupees Ten Crores only) as first quarter amount of 2008-2009 from the budget provisions of Rs.20 Crores for the year 2008-2009 to the Tamilnadu Manual Workers Welfare Board and 11 other Welfare Boards as indicated below for settlement of pending claim petitions received from the beneficiaries of the Welfare Boards.

2. In the letters second and third read above, the Commissioner of Labour has sent a proposal requesting for sanction of additional Grant for a sum of Rs.35.69 Crores including a sum of Rs.10 Crores which is the balance of provisions available in the budget estimate 2008-2009 towards the payment of salaries and administrative expenses and for settlement of various welfare assistance to the beneficiaries in respect of Tamil Nadu Manual Workers Welfare Board and 11 other Boards for the year 2008-2009 for the periods from 10/2008 to 3/2009.

3. In the letter fourth read above, orders have been issued permitting the Commissioner of Labour, Chennai – 6 to incur an expenditure upto the level of Rs.20 Crores (not exceeding rupees twenty crores) from the Budget Provision 2008-2009 in relaxation of the orders issued on the Quarterly Control of Appropriation system for the year 2008-2009.

4. The Government after careful consideration, accord sanction for incurring an expenditure of Rs.10 Crores (Rupees Ten Crores only) as Grant from the balance available in the budget estimate 2008-2009 to Tamil Nadu Manual Workers Welfare Board and 11 other Boards for settlement of pending claim petitions by relaxing the Quarterly Control of Appropriation system for the year 2008-2009.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

6. The Government authorize the Administrative Officer (Minimum Wages), Office of the Commissioner of Labour to draw and disburse the amount to the Secretary, Tamil Nadu Manual Workers Welfare Board, Chennai for apportioning the amount sanctioned in
