In the G.O. first read above, the Government have established Tamil Nadu Goldsmiths Welfare Board with effect from 1.9.2006.

The non-official members of the Board shall hold office for a period of two years commencing on and from the date on which his appointment is first notified in the Tamil Nadu Government Gazette, as per sub-rule (2) of rule 19 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Rules, 1986.

6. The Board shall be treated as a First Class Committee for the purpose of Travelling Allowance and Daily Allowance. The Chief Executive Officer/Secretary, Tamil Nadu
