Employment and Training Department – Training Wing – Starting of a new Government Industrial Training Institute at Perambalur in Perambalur District – Orders –Issued.

From the Special Commissioner and Commissioner of Employment and Training, letter No. Plan 3/8768/2007 dated 23.2.2007, 4.4.2007 and 21.5.2007.

ORDER:

An announcement was made by the Honorable Minister for Finance on the floor of the Tamil Nadu Legislative Assembly on 28.3.2007 during the Budget Speech for the year 2007-2008 that,

- "With a view to ensuring that the local youth get the benefit of the employment opportunities generated by the Special Economic Zone to be established in Perambalur district, two new Government Industrial Training Institutes will be set up in that district and a new Government Industrial Training Institute will be started in Sivagangai district next year".
- 2. The Special Commissioner and Commissioner of Employment and Training in the letters read above, has sent proposals to the Government in pursuance with the said announcement. She has requested that, for meeting the skilled man power requirement of the proposed Special Economic Zone and Jayamkondam Lignite Power Project, an Industrial Training Institute, within the Special Economic Zone, Perambalur may be started with the following engineering trades.

1. Fitter - 2 Years
2. Turner - 2 Years
3. Machinist - 2 Years
4. Electrician - 2 Years
5. Welder - 1 Year
6. Mechanic Motor Vehicle - 2 Years

She has stated that Trades relating to Textile, Leather, Pharma sectors, etc. may be started in due course, once the Special Economic Zone becomes operational and has sent the details of the trades to be

started, cost of tools and equipments, establishment charges, etc., and the staff requirement as per the National Council for Vocational Training norms. She has added that no surplus staff is available in Employment and Training department for deployment and that staff are to be sanctioned by creation.

- 3. The Special Commissioner and Commissioner of Employment and Training has stated that for starting the Industrial Training Institute, 20 acres of land is required including for future expansion and the land may be allotted within Special Economic Zone in a suitable location, so that both boys and girls undergo training in the Industrial Training She has not included the cost for building in the proposal, though buildings including hostel for 100 trainees are essential as per National Council for Vocational Training norms for starting the courses. The carpet area required for administrative building including class room, workshop, hostel etc. comes to 2370.20 Sq.m. She has suggested that the required building has to be constructed before starting the courses. She has suggested that the buildings may be constructed out of area development fund of MP/ MLAs and that before starting the construction work, building plan may be prepared in consultation with the Employment and Training department and that the Industrial Training Institute may be started in August 2007 and till the construction work is completed, the Industrial Training Institute may function in a rented building. She has requested for sanctioning a sum of Rs.377.28 lakhs (recurring Rs.61.28 lakhs + non-recurring Rs.316.00 lakhs), restricting the expenditure to Rs. 345.34 lakhs (recurring Rs.29.34 lakhs and non-recurring Rs.316.00 lakhs) for the year 2007-2008 and a new head of account may be opened and necessary funds be provided in BE 2007-2008 so as to start the course in August 2007.
- 4. The Government have examined the proposal in detail and accord sanction for starting of the new Government Industrial Training Institute at Perambalur in Perambalur District with the trades, units, duration and the total number of seats indicated against each mentioned in Annexure I to this order. The Government also accord sanction for the staff by creation of new posts as mentioned in Annexure II and for the cost of Tools & Equipments and the furniture as per Annexure III to this order.
- 5. The Government also accord sanction for a sum of Rs.345.34 lakhs (Rupees Three hundred forty five lakhs and thirty four thousands only) (i.e recurring Rs. 29.34 lakhs + non-recurring Rs.316.00 lakhs) for starting the Industrial Training Institute with 224 seats, mentioned in Annexure IV to this order.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following existing Head of Account:

"2230- Labour and Employment – 03- Training – 101-Industrial Training Institutes – Schemes in the Eleventh Five Year Plan - I Non – Plan – AA – Industrial Training Institutes."
