



ABSTRACT

Employment and Training Department – Training Wing – Starting of a new Government Industrial Training Institute at Sivagangai – Orders –Issued.

From the Special Commissioner and Commissioner of Employment and Training , letter No. Plan 3/16915/2007 dated 3.4.2007 and 22.5.2007.

ORDER:

An announcement was made by the Honorable Minister for Finance on the floor of the Tamil Nadu Legislative Assembly on 28.3.2007 during the Budget Speech for the year 2007-2008 that,

“ With a view to ensuring that the local youth get the benefit of the employment opportunities generated by the Special Economic Zone to be established in Perambalur district, two new Government Industrial Training Institutes will be set up in that district and a new Government Industrial Training Institute will be started in Sivagangai district next year”.

2. The Special Commissioner and Commissioner of Employment and Training in the letters read above, has sent proposal to the Government in pursuance with the said announcement. She has stated that the Sivagangai is one of the backward districts in the southern part of the State, that owing to poverty, considerable number of candidates are unable to pursue higher studies after Schooling and that most of them remain unemployed. She has stated that if industrial training is given to these candidates they can get employment in the industry available in and around Sivagangai and nearby Industrial areas. She has proposed to start a Government Industrial Training Institute at Sivagangai with the following trades:

She has stated that for starting the Industrial Training Institute, 15 acres of land is required and that the land may be allotted from Government promboke land. She has stated that building for the Industrial Training Institute including hostel for 60 trainees are essential as per National Council for Vocational Training norms for starting the courses. (The carpet area required for administrative building, class room, workshop etc. comes to 1949 Sq.m.) and that the Industrial Training Institute may be started in August, 2007 and function in a rented building till the construction of building.

3. The Special Commissioner and Commissioner of Employment and Training has sent the details of the trade to be started cost of tools and equipments, the details of establishment charges, etc., and the staff requirement as per the National Council for Vocational Training norms. She has added that no surplus staff is available in Employment and Training Department for deployment and that staff are to be sanctioned by creation. She has requested for sanctioning a sum of Rs.336.99 lakhs (recurring Rs.58.27 lakhs and non-recurring Rs.278.72 lakhs) restricting the expenditure to Rs.207.91 lakhs (recurring Rs.29.19 lakhs and non-recurring Rs.178.72 lakhs) for the year 2007-2008 and has requested that a new head of account may be opened and necessary funds be provided in BE 2007-2008 to start the course in August 2007.

4. The Government have examined the proposal in detail and accord sanction for starting of the new Government Industrial Training Institute at Sivagangai with the trades, units, duration and the total number of seats indicated against each mentioned in Annexure - I to this order. The Government also accord sanction the staff by creation of new posts as mentioned in Annexure - II and for the cost of Tools and Equipments and the furniture as per Annexure - III to this order.

5. The Government also accord sanction for a sum of Rs.207.91 lakhs (Rupees Two hundred and seven lakhs and ninety one thousands only) (recurring Rs.29.19 lakhs and non-recurring Rs.178.72 lakhs) for starting the Industrial Training Institute with 224 seats mentioned in the Annexure - IV to this order.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of Account:
