ORDER:

In the Govt. order first read above, orders were issued notifying the officers of Labour department as 'Inspectors' under the Inter state Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act XXX of 1979) as per Section 20(1) of the said Act by assigning respective jurisdictions under the relevant Acts.

2. The Chief Inspector of Factories has sent proposals in the letter second read above requesting the Government to notify the officers of the Inspectorate of Factories and assigning jurisdictions ie. local limits under the Factories Act as per sub section (1) of Section 8 of the said Act (Central Act LXIII of 1948) by exercising the powers conferred by sub section (1) of Section 20 of the Inter state Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act, XXX of 1979). so as to avoid legal implications by Inspectorate. The Commissioner of Labour, in his letter third read above, has stated that since the Inspectorate of Factories department was separated from Labour department, the officials of both the Departments exercise powers vested with them under the various provisions of Labour enactments separately. He has also stated that the officers of both the Labour department and Inspectorate of Factories department can be notified to exercise the powers under the above provision of the Act.

3. In the circumstances stated above by the Commissioner of Labour, and Chief Inspector of Factories Chennai, the Government, after careful consideration, decided to issue amendment to Notification III issued with the G.O. first read above by notifying the Officers of Chief Inspector of Factories, Additional Chief Inspector of Factories, Joint Chief Inspector of Factories, Deputy Chief Inspector of Factories Inspectors of Factories, assistant Inspector of Factories as the authority for the whole of the State of Tamil Nadu under the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979.

4. The appended notification shall be published in the Tamil Nadu Government Gazette both in the English and Tamil.

5. The Secretary to Government, Tamil Development and Culture (Translations) and Religious Endowments department is requested to send the Tamil version of the Notification direct to the Works Manager, Government Central Press, Chennai-79 for publication in the Tamil Nadu Government Gazette.
