ORDER:

The Government, in their order first read above, divided the Thalainar Sakthi Estates of Plantations into Private individuals Plantations, as mentioned in the schedule to the said G.O. and notified under Section 1(5) of the Plantations Labour Act 1951.

- 2. The Commissioner of Labour in his letters second and third read above has stated that the owners of the 19 Estates except one Thiru Senthil Saravanan notified in the G.O.first read above and Thiru V.A.Muthu Manickam, have made partnership deed among them and formed a new Estate namely Sakthi Coffee Estate Private Limited and requested the Inspector of Plantations. The Nilgiris to register their Estates under the Plantation Labour Act 1951. The Commissioner of Labour has also stated that Thiru Senthilkumar has also made application to the Inspector of Plantations. The Nilgiris to register his Estate under the said Act. After canceling the notification issued in the G.O.first read above, the Inspector of Plantations can register the Sakthi Coffee Estate Plantation Limited and the Senthil Saravanan Estate under the said Act. Hence the Commissioner of Labour has requested the Government to cancel the notification published under section 1(5) of the Plantation Labour Act 1951.
- 3. In the circumstances stated by the Commissioner of Labour, the Government after careful examination accept his recommendation to cancel the earlier Notification approved in the Government Order first read above and published in the Tamil Nadu Government Gazette. The appended Notification will be published in the Tamil Nadu Government Gazette in English and Tamil.
