ORDER

In the G.O. first read above, the Government, among others, established the Tamil Nadu Handloom and Handloom Silk Weaving Workers Welfare Board, with effect from 1.9.2006.

2. In the G.O second read above, the Government issued notification for nomination of the Chairman and Members to the Tamil Nadu Handloom and Handloom Silk Weaving Workers Welfare Board; and the notification was published in the Tamil Nadu Government Gazette on 8.8.2007.

3. The Secretary to Government, Handloom, Handicrafts, Textiles and Khadi Department has stated that the Handloom and Textiles activities are coming under the control of Handloom, Handicrafts, Textiles and Khadi Department and it is considered appropriate that the Secretary to Government of that department may also be nominated as a member in the Tamil Nadu Handloom and Handloom Silk Weaving Workers Welfare Board.

He has therefore requested to include him as one of the member of the above Board.

4. After examination, the Government have decided to nominate “the Secretary to Government, Handloom, Handicrafts, Textile and Khadi Department”, as representative of Government in addition to the members already nominated to the Tamil Nadu Handloom and Handloom Silk Weaving Workers Welfare Board.

5. Accordingly, the appended Notification will be published in the **Tamil Nadu Government Gazette** both in English and Tamil. The Works Manager, Government Central Press, Chennai, is requested to send 5 copies of the Gazette to the Government and 5 copies to the Commissioner of Labour, Chennai-6.

6. The Secretary, Tamil Development, Religious Endowments and Information (Translations) Department will furnish the Tamil version of the Notification to the Works Manager, Government Central Press, Chennai for publication in the Gazette.
