## ORDER:

In the Government Order first read above, a Preliminary Notification containing proposals to revise further the minimum rates of wages for the employment in laundries and washing clothes (including woollen) was issued and objection and suggestion were invited from the persons likely to be affected by such revision.

## APPENDIX NOTIFICATION

In exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in supersession of the Labour and Employment Department Notification No. II(2)/LE/435/2004, published at page 274 of Part II- Section 2 of the Tamil Nadu Government Gazette, dated the 23<sup>rd</sup> June 2004, the Governor of Tamil Nadu after consultation with the Advisory Board, hereby revises the minimum rates of wages payable to the classes of work in the employment in laundries and washing clothes (including woollen) in the State of Tamil Nadu specified in column (2) of the Schedule below, as specified in the corresponding entries in column (3) thereof, the draft of the same having been previously published as required by clause (b) of sub-section (1) of section 5 of the said Act.

2. This Notification shall come into force on and from the dates of its publication in the Tamil Nadu Government Gazette.

**Explanations:** (1) The minimum rates of wages shall be paid in cash.

- (2) <u>Dearness allowance</u>.-- In addition to the basic wages mentioned above, the employees shall be paid dearness allowance as indicated below:-
  - (i) The wages notified above shall be linked to the Average Chennai City Consumer Price Index for the year 2000 (i.e.) 475 points with base 1982=100 and for every rise of one point over and above 475 points, an increase of 29 paise (Twenty nine paise only) shall be paid as dearness allowance per day.

- (ii) The revision of the dearness allowance shall be effective from the 1<sup>st</sup> April of every year on the basis of the average of the indices for the earlier twelve months, that is from January to December.
- (iii) The calculation shall be effective from the date of publication of the Notification in the <u>Tamil Nadu Government Gazette</u> based on the Average Consumer Price Index of the previous year. (i.e. from January to December)
- (3) Where the nature of work is the same, no distinction in the payment of wages shall be made between men and women employees.
- (4) The daily rate of wages and dearness allowance shall include the element of holidays wages also.
- (5) To arrive at monthly wages, the daily wages shall be multiplied by 30.
- (6) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
