- 2. The Government direct that under rule 2(a) of the Special Rules for the Tamil Nadu Employment and Training Service, the candidates mentioned above be appointed as Principal, Industrial Training Institute / Assistant Director of Training in the Tamil Nadu Employment and Training Service in the order of seniority fixed by the Tamil Nadu Public Service Commission and their appointment is purely provisional subject to the final outcome of the any Cases / WPs pending on the files of High Court, Chennai / Madurai relating to this recruitment.
- 3. The above candidates mentioned are informed that they shall, from the date of joining, be on probation for a period of two years on duty within a continuous period of three years and during the period of probation, they should pass the Account Test for Executive Officers. If they have already passed the Account Test for Executive Officer, they need not pass the test again.
- 4. The candidates appointed above should undergo a course of training as may be prescribed by the Director of Employment and Training for a period of 3 weeks, during the period of probation.
- 5. The candidates should undergo foundational course at the Civil Service Training Institute, Bhavanisagar and they should pass the test conducted after completion of the Foundational course and a pass in the test is pre-condition for the declaration of probation. The period of training shall be treated as duty. The Scale of Pay of the candidates be fixed as Rs. 15,600 39,100 GP Rs. 5,400 applicable to the post.
- 6. The Commissioner of Employment and Training, Chennai is directed to give postings and intimate the date on which the Principal Industrial Training Institute / Assistant Director of Training selected by Tamil Nadu Public Service Commission mentioned in para 1 above report for duty. No kind of representation regarding joining duty on a later date would be entertained and that failure to join duty within the specified time and at the specified place would result in his / her name being removed from the approved list.

7. The Commissioner of Employment and Training is requested that as soon as the selected candidates join duty, it may be ascertained from them whether they have registered their names with any Employment Exchange. If so they may be asked to surrender their Employment Exchange identity card, and the same may be sent by you either to the Employment Exchange, where such candidates have registered their names or to the Director of Employment and Training, Chennai so that the registration of the concerned candidates may be removed from the Live Register of the Employment Exchange.
