**The following Notification will be published in the Tamil Nadu Government Gazette**

### **NOTIFICATION**

**WHEREAS, the Governor of Tamil Nadu is satisfied that public interest requires that “ All the co-operative Institutions registered under the Tamil Nadu Co-operative Societies Act, 1983 (Tamil Nadu Act 30 of 1983) engaged in procurement, storage and distribution of essential commodities” should be declared to be a Public Utility Service for the purposes of the Industrial Disputes Act 1947 (Central Act XIV of 1947);**

NOW, THEREFORE, in exercise of the powers conferred by sub-clause (vi) of clause (n) of section 2 of the Industrial Disputes Act, 1947 (Central Act XIV of 1947), the Governor of Tamil Nadu hereby declares all the Co-operative Institutions registered under the Tamil Nadu Co-operative Societies Act, 1983 (Tamil Nadu Act 30 of 1983) engaged in procurement, storage and distribution of essential commodities, to be public utility services for the purposes of the said Central Act XIV of 1947 for a period of six months with effect as and from the date of publication of this Notification in the Tamil Nadu Government Gazette.
