**ORDER:**

In the Government Order first read above, a Preliminary Notification containing proposal to delete the employment in Chemical and distillery industry from Part-I of the schedule to the Minimum Wages Act, 1948 (Central Act XI of 1948) was issued and objection and suggestion were invited within the specified period of three months from the persons likely to be affected by such notification before confirmation of the notification. As there is no objection or suggestion received from the public within the said period of three months from the date of publication of the notification in the Tamil Nadu Government Gazette dated 31.10.2007. Government have decided to confirm the notification published in the Government Order first read above.

2. The appended Notification will accordingly be published in the Tamil Nadu Government Gazette both in English and Tamil. **NOTIFICATION**
