**ORDER:**

In the Government Order first read above, a Preliminary Notification was issued for inclusion in Part –I of the schedule to the Minimum Wages Act, 1948 (Central Act 1948), the employment in Chemical Industry and objection and suggestion were invited within the specified period of three months from the persons likely to be affected by such inclusion. As there is no objection or suggestion received from the public with in the specified period of three months from the date of publication of the notification in the Tamil Nadu Government Gazette dated 31.10.2007 Government have decided to confirm the Notification published in the Government order first read above.

In the said Act, in the Schedule, in Part-I, after the expression “ 89, Employment in Domestic Works”, the expression “90. Employment in Chemical Industry” shall be added.
