

#### **ABSTRACT**

Minimum Wages Act, (Central Act XI of 1948) 1948 - Revision of minimum rates of wages for employment in Tanneries and Leather Manufactory - Preliminary Notification - issued.

ORDER:

In the Government Order first read above the minimum rates of wages for the employment in Tanneries and Leather Manufactory were fixed under the provisions of the Minimum Wages Act, 1948 (Central Act XI of 1948). The Government have now proposed to further revise these minimum rates of wages for employment in Tanneries and Leather Manufactory.

2. The appended Notification will accordingly be published in the <u>Tamil Nadu Government Gazette</u> both in English and Tamil. # APPENDIX. NOTIFIFCATION.

The following draft of a Notification which it is proposed to issue in exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) is hereby published for information of all persons likely to be affected thereby, as required by clause (b) of sub-section (1) of section 5 of the said Act.

2. Notice is hereby given that the draft Notification will be taken into consideration on or after the expiry of two months from the date of publication of this Notification in the <u>Tamil Nadu Government Gazette</u> and that any objection or suggestion, which may be received from any person with respect thereto before the expiry of the aforesaid period will be considered by the Government of Tamil Nadu. Objection or suggestion, if any, should be addressed to the Principal Secretary to Government, Labour and Employment Department, Secretariat, Chennai-600 009 through the Commissioner of Labour, Chennai - 600 006.

### **DRAFT NOTIFICATION.**

In exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in supersession of the Labour and Employment Department Notification No. II(2)/LE/241/2007, published at page 193 and 194 of Part II Section 2 of the <u>Tamil Nadu Government Gazette</u>, Dated the 9<sup>th</sup> May 2007, the Governor of Tamil Nadu hereby revises the minimum rates of wages payable to the classes of employees in the employment in Tanneries and Leather Manufactory in the State of Tamil Nadu Specified in column (1) of the Schedule below, as specified in the corresponding entries in column (2) thereof.

### **OTHER TANNERIES:**

- (i) Tanning of Skin and hides in the limepit or barkpit, the wages shall be paid at Rs.22.63 for the first unit and Rs.2.36 per every additional unit of work done.
- (ii) Un-skilled workers Rs.66.00 per day.

### **PIECE RATE WORKERS:**

The wages shall be paid at Rs.35.36 for the work done in respect of first unit and Rs.15.56 for every additional unit of work done. Rs.2.36 shall be paid every additional unit of work done in lime and bark pit.

# **GENERAL CATEGORIES IN TANNERIES AND LEATHER MANUFACTORY:**

(1) Clerk / Cashier Rs.2060.00 per month.

(2) Maistries or Supervisors Rs.2060.00 per month.

(3) Watchman Rs.2021.00 per month.

## **EXPLANATIONS.-**

(i) The employees shall be paid dearness allowance in addition to the minimum rates of basic wages specified above. For calculation of dearness allowance, the base shall be taken as 2174 (base 1960=100) being the average of All India Consumer Price Index Number for the year 2000. For further rise of one point over and above 2174 points, an increase of 3 paise (three paise only) shall be paid per day.

- (ii) Where the nature of work is the same, no distinction in the payment of wages shall be made as between men and women employees.
- (iii) Where piece rate workers are employed in any Tannery and Leather Manufactory, the wages paid to each of them for a normal working day shall not be less than the minimum rates of wages fixed for that category.
- (iv) To arrive at daily wages, the monthly wages shall be divided by 26.
- (v) To arrive at monthly wages, the daily wages shall be multiplied by 30.
- (vi) Wherever the existing wages are higher than the minimum wages fixed herein, the existing wages shall be continued to be paid.
