ORDER:

In the letter 1st read above, the Special Commissioner and Commissioner of Employment and Training had sent the Project Report for getting assistance under ASIDE scheme from the Industrial Guidance and Export Promotion Bureau, for starting Knitwear Training Centres in five Government Industrial Training Institutes at Trichirapalli, Madurai, Tirunelveli (Pettai), Dharmapuri and Tiruvannamalai. She has requested for

sanction of the State Government share of Rs.5.25 lakhs as recurring expenditure, to these 5 centres, as indicated below:-

	<u>for 3 months</u> (one time)
1. Cost of consumable for 5 Centres at the rate of Rs.20,000/-per Centre	-Rs.1,00,000
2. Honorarium to be paid to contract Faculty (Rs.5000x3 Months x 5 Centres)	Rs. 75,000
Total	Rs. 1,75,000
Total for 3 times in a year (Rs.1,75,000x3=Rs.5,25,000)= Rs. 5,25,000/-	

2. The Special Commissioner and Commissioner of Employment and Training has stated that the Industrial Guidance and Export Promotion Bureau, has sanctioned a sum of Rs.2 Crores through the Tamil Nadu Industrial Development Corporation Limited, the Nodal Agency of ASIDE Scheme as non-recurring expenditure for establishing infrastructures in the above five centres for starting short term knitwear training courses. She has requested for permission to establish the Knitwear Training Centres at Government Industrial Training Institute, Hosur in Krishnagiri District instead of Trichirappalli, as orders have already been issued for starting Knitwear and Sewing Machine Operator Training in Trichirappalli. She has requested the Government to accord permission for starting knitwear training course in five Government Industrial Training Institutes at Madurai, Tirunelveli (Pettai), Dharmapuri, Tiruvannamalai and Hosur (in Krishnagiri District) w.e.f. 1.7.2007 with requirement of 2000 sq.ft. space in each centre. She has also requested to permit her for opening a new account in State Bank of India, Guindy Chennai, to receive the grant from Tamil Nadu Industrial Development Corporation Limited, the Nodal Agency of ASIDE Scheme.

3. The Government, after careful examination of the proposal referred to at para 2 above, permit the Special Commissioner and Commissioner of Employment and Training to

start short term courses at Government Industrial Training Institutes at Madurai, Tirunvelveli (Pettai), Dharmapuri, Tiruvannamalai and Hosur (in Krishnagiri District) with effect from 1.7.2007 with requirement of 2000 sq.ft. in each centre. Sanction is also accorded for a sum of Rs.5.25 lakhs (Rupees five lakhs and twenty five thousand only) per year for the above 5 centres (each Centre 35,000 x 3 = Rs.1,05,000/- per year) as recurring expenditure. The grant received from Industrial Guidance and Export Promotion Bureau, through the Nodal Agency, Tamil Nadu Industrial Development Corporation Limited, under ASIDE scheme shall be credited in the name of the Society formed for the purpose by opening a new account in the State Bank of India, Guindy, Chennai.

4. The expenditure sanctioned in para 3 above, shall be debited to the following head of account:-

5) The Special Commissioner and Commissioner of Employment and Training will be the estimating reconciling and controlling authority of the above new sub-head of account. The Pay and Accounts Officer / Treasury Officer is requested to open the above new sub-head of account in their accounts.

6) Necessary funds will be provided in Revised Estimate/Final Modified Appropriation 2007-2008. Pending provision of funds in the Revised Estimate/Final Modified Appropriation 2007-2008, the Special Commissioner and Commissioner of Employment and Training is authorized to draw and incur the expenditure. The Special Commissioner and Commissioner of Employment and Training is also requested to include this expenditure while sending proposals of Revised Estimate/Final Modified Appropriation 2007-2008 at appropriate time without fail.
